**Sub: Violation of Punjab Procurement Rules 2014, District Education Officer, Sargodha's
Tender Notice for Supply of Miscellaneous Items.**

Dear Sir,

This is with reference to District Education Officer, Sargodha's Tender Notice, published in daily "Nawaiwaqt" on 17th September, 2017. It is observed that the advertisement is in violation of the PPRA Rules 2014.

As per advertisement, "The Company is authorized to reject any bid/all bid without any reason". However, it is not complying with, PPRA 2014, Rule No. 35, which requires that reason should be communicated to bidders. Therefore the advertisement is in violation of Rule No. 35 of PPRA Rules 2014. Stated as under;

35. Rejection of Bids :- (1) *the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.*
(2) *the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- 3 Bidding documents may be obtained from the date of publication of Tender from office of the District Education Officer (M-EE) Sargodha by submitting written request or letter or letter head of the company / firm upto 06-10-2017 during working hours on cash payment of Rs.500/-
- 4 Successful bidders will have to submit 2% of the amount of supply orders as performance security in the form of CDR in favour of District Education Officer (M-EE), Sargodha.
- 5 The firms / companies must be registered with sales tax and income tax Department (copy of NTN certificate and Sale Tax Certificate) must be provided.
- 6 The firms / companies must produced proof of financial sources.
- 7 5% of total amount will be Deposited as call deposit in shape of CDR in favour of DEO (M-EE) Sargodha.
- 8 Successful bidders will have to supply the above items with in 30 days after issuance of work order/Supply order.
- 9 As provided in the bidding documents, the bidders engaged in corruption or fraudulent practice will be declared ineligible.
- 10 The firm / company will provide affidavit on Ishtam Paper of 100/- that firm not involved in any case or not blacklisted in any Department of Punjab.
- 11 The committee is authorized to reject any bid / all bids without any reason and decision of the committee will not be challenged in any court.
