Sub: Violation of Punjab Procurement Rules 2014, District Officer (Buildings), Secretary
District Tendering Board, Sheikhpura's Short Tender Notice for Construction,
Rehabilitation & Improvement, M&R & Repairs Works.

Dear Sir,

This is with reference to District Officer (Buildings), Sheikhpura's Short Tender Notice, published in daily "Nawaiwaqt" on 29th August, 2016. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, there is an ambiguity; as the tender closing date is given as 21-09-16, while opening date is given as 19-09-16, which is incorrect. It is violation of PPRA 2014, Rule 30(1). Stated as under;

30. Opening of bids.— (1) The date for opening of bids and the last date for the submission of bids shall be the same; and, bids shall be opened at the time specified in the bidding documents which shall not less than thirty minutes after the closing time for the submission of bids.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

No tender will be issued after the last date of issuance of tenders as indicated in the tender notice. Tenders / Bidding documents after the date of publication will be issued up to 19- 9 -2016 during the office hours and tenders will be received on 21- 9 -2016 upto 01:00 (P.M) (Under PPRA Rules 30) in the Zila Council Hall Sheikhupura, which will be opened on 19- 9 -2016 at 01:30 (P.M) there after by the District Tender Board, Sheikhupura, in the presence of intending contractors.

Conditional tenders and, attested copies of registered partnership deed and power of attorney in case of firms will not be entertained. (Printing charges in shape of Deposit Call will be received at the time of issuance of the tender.

If the rates quoted by the contractors / firms are below 5% or more, the contractors / firms will be bound to deposit additional performance security from a scheduled bank within 15 days.

The Procuring agency may reject all bids at any time prior to the acceptance of a bid. (Under PPRA Rules 35)The procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids, but shall not be required to justify those grounds.

The record relating to the works may be examined in the office of the undersigned if desired. The provisions of T.S estimate will be the final in case of any omission.
