It is further submitted that there is no intention of violation of the PPR-2014, as it has been clearly elaborated under Section 1: Instruction to Applicants (ITA), Sub Heading F: Evaluation of Applications and Prequalification of Applicants at Sr. No. 24 (24.1), Page No. 6 of the EOI Document that "The Procuring Agency reserves the right to accept or reject all the applications and to annul the prequalification process, as provided under relevant section of PPRA rules" (Copy attached). Thus, the whole consultancy procurement process under the reference advertisement shall be carried out as per the PPR-2014 amended upto-date.
