The bids are invited for first two circulations/magazines. Sales tax registered Publishers having relevant experience of development of magazines are invited to submit their proposals, Specifications are as under:

1. Art Paper/Glazed Paper of 90 GSM for the contents	2. Magazine will consists of sixty four (64) pages (No. of pages can be increased/decreased) in all and will have two sections/portions i.e. Urdu & English with proportion of 2/3, 1/3 respectively.
3. Title cover will be printed on Art Paper/Glazed Paper of 115 GSM	4. Size of Magazine 20x30/8

The procurement of good quality art paper as per approved specifications on standard bidding documents is the responsibility of the bidder. A pre-bid meeting will be held at address given below at 1200 hours on-16.04.2018.

The estimated cost is mentioned in the Bidding Documents. Sealed bids must be delivered at the address mentioned below on or before 23.04.2018 at 1100 hours. Bid Security @ 2% of the estimated price in Pak Rupees from any scheduled Bank of Pakistan should be attached with Technical Proposal in the form of CDR/Demand Draft/Pay Order in favor of Punjab Curriculum & Textbook Board, Lahore. Late bids shall not be entertained. Technical Bids will be opened on the same day at 1130 hours in the presence of the Bidders, representatives who choose to attend.
