Sub: Violation of Punjab Procurement Rules 2014, Chairman/ Chief Officer, District Council, Narowal's Quotation Notice for Miscellaneous Works.

This is with reference to District Council, Narowal's Quotation Notice published in daily "Jang" on 16th March, 2019. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per the advertisement, there is no information regarding issuance of bidding documents for bidders, which is violation of PPRA Rules 2004, Rule No. 23 (1). Stated as under;

23. Bidding Documents: - (1) Procuring agencies shall formulate precise and unambiguous bidding documents that shall be made available to the bidders immediately after the publication of the invitation to bid.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.

2.
