Sub: Violation of Punjab Procurement Rules 2014, Water and Sanitation Agency (WASA), LDA, Lahore's Tender Notice for Improvement & Replacement Works.

Dear Sir,

This is with reference to (WASA), LDA, Lahore's Tender Notice, published in daily "Nawaiwaqt" on 19th April, 2016. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per the advertisement, two different dates for submission/ opening of tender is given, i.e., 04-05-16 and 12-04-16 which is wrong. However, the tender issued on 19-04-2016 cannot be opened on 12-04-2016. Therefore the advertisement is in violation of Punjab Procurement Rules 2014, Rule 30(1). Stated as under;

30. Opening of bids.— (1) The date for opening of bids and the last date for the submission of bids shall be the same; and, bids shall be opened at the time specified in the bidding documents which shall not less than thirty minutes after the closing time for the submission of bids.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the notice under the prescribed procedures or issue a corrigendum and extend date accordingly.

Conditional tender and tenders without attested copies of registered partnership deed and power of attorney in case firms will not be entertained.

Earnest money will be 2% of the estimated cost. Tender without earnest money will not be accepted.

No tender will be accepted which is received telegraphically or by post.

No tender will be issued on the date of receipt of tender.

WASA Lahore may reject all bids or proposals at any time prior to the acceptance of a bid or proposal as per Rule No. 35 of PPRA 2014.

WASA shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals but shall not be required to justify those grounds.

The bid will be valid for 120-days. Tender will be issued after depositing the tender fee.

NOTE:- In case the total tendered amount is less than 05% (Five) of the approved estimate (DNIT) amount the lowest bidder will have to deposit additional performance security from the scheduled Bank 5%. Any other information can be heard from the office of the undersigned during working hours.
