**Sub: Violation of Punjab Procurement Rules 2014, Executive Engineer, Faisalabad Division,
LCCW, Faisalabad's Tender Notices for Miscellaneous Works.**

Dear Sir,

This is with reference to Faisalabad Division, LCCW, Faisalabad's Tender Notice published in daily "The Nation" on 20th April, 2017. It is observed that the advertisement is in violation of the PPRA Rules, 2014.

As per the advertisement, "The amount of work is liable to be curtailed or enhanced as per site condition and checking of estimates by different Monitoring Authority of the Government". However, it is not complying with, PPRA 2014 Rule No. 35, which requires that reason should be communicated to bidders. Therefore the advertisement is in violation of Rule No. 35 of PPRA Rules 2014. Stated as under;

*35. Rejection of Bids :- (1) the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
(2) the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

3. Blank Tenders can be obtained during Office hours on payment of usual Tender Fee (Non Refundable). No Tender will be issued on the date of opening of Tenders.
4. Schedule of quantities. Specifications, drawing and other conditions etc. can be seen during the Office hours in the office of the undersigned on any working day.
5. The conditional and postal Tenders will not be accepted.
6. The procuring agency may reject all bids or proposals at any time period to the acceptance of a bid or proposal as per PPRA rule 35."(2014).
7. Incomplete/overwriting /cutting in the tender from is not acceptable.
8. All clauses of the contract agreement will be enforced at the part of the contractor.
9. Tenders forms purchased from other Division will not be accepted.
10. The amount of work is liable to be curtailed or enhanced as per site condition and checking of estimates by different Monitoring Authority of the Government.
