


Please refer to your office letter no. TL18/0201/5A, dated 02.01.2018 on the subject noted above.

## INSTRUCTIONS / TERMS & CONDITIONS.

1. The successful tenders shall deposit 05% of the total cost of store as security in the form of Call Deposit in favour of the Regional Police Officer, Bahawalpur within the period specified in Advance Acceptance of Tender and draw the contract. Security shall be refunded on successful completion of contract.
2. Tenders shall submit complete details of the firm, offices along with postal address, Phones/Fax numbers etc.
3. The tenders should specifically indicate their NTN / GST No. and Circle of the Income Tax Department.
4. Any erasing/ cutting/ crossing etc. appearing in the offer must be properly signed by the person signing the tender. Moreover, all pages to the tender must also be properly signed. Offer with any overwriting shall in no circumstances be accepted.
5. An affidavit should be provided by the tenders that their firm has never been blacklisted by any Government Department.
6. The tenders have to deposit their samples of all Items at the time of opening of the tenders otherwise the offers shall be ignored.
7. 100% payment will be made on successful completion of the Items through the office of the DAO Bahawalpur against receipt Certificate by the consignee.
8. The bidders are expected to examine the bidding documents/ tender notice including all instructions, terms & conditions, specification etc. Failure to furnish all information/ documents or submission of a bid not substantially responsive to the bidding documents/ tender notice in every respect would result in the rejection of the bid.

2 All tenders must submit their bids "Single Stage-Two Envelope Procedure" for each case as per Punjab Procurement Rules 2014, as under:-

- i) The bid shall all comprise a single package containing two separate envelopes each envelope shall contain separately the financial proposal and the technical proposal.
- ii) The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion.
- iii) The envelop marked as "FINANCIAL PROPOSAL" shall be retained in the custody of the Police Department without being opened.
- v) The Technical Committee of the Police Department shall evaluate the technical proposal in a manner prescribed in advance, without reference to the price and reject any proposal which does not confirm to the specified requirements.
- vi) During the technical evaluation no amendments in the technical proposal shall be permitted.
- vii) The financial proposals of bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance.
- viii) After the evaluation and approval of the technical proposal the Police Department, shall publicly open the financial proposals of the technically accepted bids only. The financial proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders, and
- ix) The bid found to be the lowest evaluated bid shall be accepted.
- x) Estimated price of tender is Five Hundred Thousand Only.
- xi) The bidder furnishes a bid security not exceeding 05 % of the estimated price.

The purchaser reserves the rights to purchase full or part of Items cancel the tender without assigning any reasons. The purchaser has also increased/ decreased the quantity of store as per requirement.
