Sub: Violation of Punjab Procurement Rules 2014, Director Breed Improvement, Livestock and Dairy Development Department, Punjab, Lahore's Tender Notice for Purchase of Approximately 1, 50, 000 Doses of Exotic Semen.

Dear Sir,

This is with reference to L&DD, Punjab, Lahore's Tender Notice, published in daily "The News" on 21st April, 2017. It is observed that the advertisement is in violation of the Punjab Procurement Rules 2014.


As per advertisement, L&DD, Punjab, Lahore has restricted the bidder to supply Doses of Exotic Semen of USA/ Canada originated only and has not added "**or equivalent**" with it, which is not allowed under PPRA 2014, Rule No. 10(2). Stated as under:

10. Specifications:- (2) The Specifications shall be generic and shall not include references to brand names, model numbers, catalogue numbers or similar classifications but if the procuring agency is satisfied that the use of, or a reference to, a brand name or a catalogue number is essential to complete an otherwise incomplete specification, such use or reference shall be qualified with the words "or equivalent".

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.

Directorate of Breed Improvement, L&DD, Punjab, Lahore invites sealed tenders on FOR basis from sales tax/income tax registered firms for the purchase of approximately 1,50,000 doses Exotic semen (conventional) of good quality progeny tested Holstein Friesian breed or equivalent cattle (conventional) having normal Karyotype, free from genetic and venereal diseases, with accuracy/reliability of 80% or more. Country of origin should be USA /Canada, packed in straws of 0.25 / 0.5 ml capacity carrying at least 10 million sperms, to be supplied duly preserved in liquid nitrogen through revolving funds, Rs. 35.000 million approximately. The bidder will make available at least 2 bulls of Holstein Friesian breed for each slab as detailed in technical specifications and mandatorily provide Electropherogram of the bulls ordered for purchase. This is not intended to get donated/rejected semen or semen from test bulls. The detailed specifications/tender documents along with copy of terms & condition can be obtained by submitting written request on payment of Rs.500/- non refundable from the office of Director, Breed Improvement, L&DD Punjab, 16 -Cooper Road, Lahore during office hours. Bidding documents are available from the date of uploading on PPRA website. The tenders should reach in the office of undersigned on 15.05.2017 till 11.00 A.M. The tenders (technical proposals) will be opened on the same day at 11.30 AM in the presence of tenderers or their authorized representatives. 2% bid security of estimated value i.e. Rs.35.000 million in the name of Director Breed Improvement, L&DD, Punjab, Lahore in shape of call deposit (CDR) should be attached with the financial proposal by each bidder. The procuring agency may reject all bids or proposals at any time prior to the acceptance of bid or proposal according to the PPRA rule, 2014.
