**Sub: Violation of Punjab Procurement Rules 2014, Executive District Officer (Education),  
Mandi Bahauddin's Tender Notice for Purchase of Uniform for Male & Female Students.**

Dear Sir,

This is with reference to Executive District Officer (Education), Mandi Bahauddin's Tender Notice, published in daily "Dawn" on 19<sup>th</sup> March, 2016. It is observed that the advertisement is in violation of the PPRA Rules 2014.


As per advertisement, "Work order can be increased/ decreased in proportion to the increase/decrease in the male and female students", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPRA 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

*59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:  
(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:  
(iv) repeat orders not exceeding fifteen per cent of the original procurement;*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
