Sub: Violation of Punjab Procurement Rules 2014, Deputy Commissioner/ Chairman, District Disaster Management Authority, Khanewal's Pre-Qualification Notice for Supply of Food Items.

Dear Sir,

This is with reference to District Disaster Management Authority, Khanewal's Pre-Qualification Notice published in daily "Jang" on 20th May, 2017. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, 15 days of response time is not given and the last date for submission of tenders is on 31-05-2017, which is 3 days short. It is violation of PPRA 2014, Rule No.14 (1). Stated as under;

14. Response time:- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.

1.	Food Hamper (Ghee shall be packed in a poly bag separately, duly sealed with sealer in addition to its original packing)	Vendors are required at District level.
2.	Rice (2 Kg)	
3.	Drinking water, Atta, Cooked Food, Catering and Transport etc.	
1.	Prequalification of firms shall be made in accordance with Punjab Procurement Regularity Authority, Rules 2014.	
2.	Prequalification documents along with standardized specification of the relief goods/equipment are available at PPRA's website, and also can be obtained from the undersigned's office during the office hours.	
3.	Preference shall be given to those Authorized Dealers/Distributors/wholesalers/stockiest/General order suppliers who have their supply set up (s) at District/Divisional Level.	
4.	Technical proposal (s) for each Lot shall accompany with a receipt of cash deposit @ Rs.500/- Draft worth Rs. 500/- in the name of Deputy Commissioner/Chairman, District Disaster Management Authority, Khanewal on account of price of Prequalification Documents for each lot. Prequalification Documents for each lot shall be considered separately.	
5.	Financial Proposal shall accompany bid money worth Rs. 0.100 million for initial lot and if vendor desires to apply for an additional lot then Financial proposal for each subsequent/additional lot shall accompany a demand draft worth Rs. 0.050/- million for each additional lot. Demand Draft will be prepared in the name of Deputy Commissioner/Chairman, District Disaster Management Authority, Khanewal	
6.	Prequalification Documents; Technical Proposal/Company Profile must be provided in two separate sealed envelopes, 1 st marked as Original Prequalification Documents and 2 nd as Duplicate Prequalification Documents for each lot duly completed and should be dropped, in the Box, placed at reception of the Committee Room of DC office, Khanewal	
7.	Prequalification Documents which are incomplete, not sealed and late or submitted by other than specified mode shall be returned un-opened.	
8.	Sample of each lot shall be deposited with Addl: Deputy Commissioner (Finance) Khanewal at DC complex, Khanewal within office hours before a day of closing date. Technical Proposal must accompany the sample deposit receipt.	
9.	Deadline for filing Prequalification Documents is 01.00 PM on 31.05.2017	
10.	Technical Bids shall be opened on the same date at 01.30 PM i.e. After 30 Minutes of closing time, in the presence of firms/their authorized representatives.	
11.	Financial Proposal of only those vendors / firms shall be opened who will prequalify and whose samples will also qualify under this process.
