Sub: Violation of Punjab Procurement Rules 2014, Chairman/ Chief Officer, Municipal Committee,
Kabirwala's Tender Notice for Construction Works.

Dear Sir,

This is with reference to Municipal Committee, Kabirwala's Tender Notice published in daily "Dawn" on 20th May, 2018. It is observed that the advertisement is in violation of the PPRA 2014.

As per the advertisement, 15 days of response time is not given and the last date for submission/ opening of bids is on 31-05-2018, which is 3 days short. It is violation of Punjab PRA Rules 2014, Rule No.14 (1). Stated as under;

14. Response time:- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.

TENDER NOTICE

Municipal Committee Kabirwala has invited sealed tenders for its development projects for the financial year 2017-18 from Registered Contractors who have got their renewal registration from any MC in Multan Division for the year 2017-18 and deposit its Govt. prevailed fee in any MC in Multan Division on the following terms, conditions & schedule of tendering:

- The contractors who are participating from other MC in Multan Division will confirm their original receipt of deposit of Govt. fee of their enlistment to Head Clerk-Engineering of (Infrastructure) branch at the time of deposit of his application.
- The terms & condition are applicable according to the Works Rules 2017.
- The bid documents can be taken from the Head Clerk (Infrastructure) branch on the payment Rs. 500/- in shape of CDR (Cost of documents) up to 29-05-2018 at 11:30 PM from the date of publication.
- All participated contractors will deposit their sealed bids along with required 5% earnest money in shape of CDR from any Schedule Bank in Punjab in favor of Chairman MC Kabirwala to Head Clerk (Infrastructure) branch from date of publication to date 31-05-2018 at 11:30 PM and will get receipt from Head Clerk (Infrastructure) on Government prescribed proforma as per Govt. instructions.
- All the received/ sealed bids will be opened on dated 31-05-2018 at 12:00 PM in the office of MC Kabirwala by the tendering opening Committee in the presence of available contractors or their authorized representative.
- It is compulsory on all participated contractors to quote their rates in numbers as well as in words on above or below the estimate on percentage basis.
- If any contractor quoted its rates below more less than 5% of estimate then he has to deposit the balance amount in the shape of CDR as additional performance security to MC within 15 days after its quoted rates approved by competent authority, if he does not deposit the required amount, His 5% CDR deposited will be forfeited by MC and his tender will be rejected and process of re-tendering will be initiated or other suitable legal option will be exercised.
- When work order issued to the approved contractor, he has to make the agreement with Municipal Committee Kabirwala on stamped paper of value specified by Government.
- Conditional, unsigned, incomplete and doubtful bids will be dealt as rejected.
- The Competent Authority may reject all bids at any time prior to the acceptance of the bid.
- Time period for completion of each project will be mentioned in work order after approval of rates of the lowest bidder.
- The tenders poured by contractors with out 5% CDR or with out getting receipt from Head Clerk (Infrastructure) will be dealt cancelled.
- The sealed tender should be with original CDR. The Tender with scanner, photo copy of CDR or Bank Draft will be considered as rejected. The bidder has not right to challenge it. The detail of tenders is as below:-
