The procuring agency has the due right to disqualify a supplier or contractor if it finds at any stage that the information submitted by him was false, fabricated or materially incorrect information under PPRA rule 19.

Sub: Violation of Punjab Procurement Rules 2014, Medical Superintendent, THQ Hospital, Kamoke's Tender Notice for Framework Contract Work.

Dear Sir,

This is with reference to THQ Hospital, Kamoke's Tender Notice published in daily "Jang" on 16th Aug, 2019. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, there is an ambiguity, 15 days of response time is not given and two different dates are mentioned for the submission/ opening of tenders, i.e 23-08-2019, which is 7 days short and 26-08-2019, which is 4 days short. It is a violation of Punjab PRA 2014, Rule No.14 (1). Stated as under;

14. Response time:- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
