Sub: Violation of Punjab Procurement Rules 2014, Manager (Admin/HR & Coord), Punjab Daanish School and Centers of Excellence Authority (PDS-CEA), Lahore's Expression of Interest (EOI) Notice for Solar Power Project.

Dear Sir,

This is with reference to (PDS-CEA), Lahore's Expression of Interest (EOI) Notice, published in daily "The News" on 21st April, 2016. It is observed that the advertisement is in violation of the Punjab Procurement Rules 2014.


As per advertisement, no criteria for short listing of bidders are issued. According to Punjab Procurement Rules 2014, Rule No. 47, the EOI document has to be issued which includes the following information as advertised as well as criteria for short listing with details of all marks that will be awarded. Stated as under;

- 47. Expression of interest.- (1) A request for expression of interest shall be advertised in accordance with the provisions of rule 12 and rule 13.*
- (2) The expression of interest shall contain the following information:*
- (a) the name and address of procuring agency;*
 - (b) an appropriate description of the assignment providing scope of the intellectual and professional services required;*
 - (c) closing date and place of the submission of the expression of interest;*
 - (d) criteria for short listing or prequalification where required; and*
 - (e) any other information that the procuring agency may deem appropriate to disseminate at this stage.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 69, and with request to re-invite the EOI Notice under the prescribed procedures, or issue a corrigendum and provide criteria for bidders, and extend date accordingly.
