

Please refer to the subject noted above following infringements of Punjab Procurement Rules 2014 (Amended 06.01.2016),/ instructions have been indicate by Transparency International Pakistan vide TL17/1404/3A dated 14.04.2017 in your Tender Notice published in daily Newspaper "**Dawn**" dated 14-04-2017 .IPL-4198.

Sr. No	Description of Omission / Violation	Violated Rule / Instructions
1.	The procuring agency may require the bidders to furnish a bid security not exceeding five percent of the estimated price. Explanation; - In this rule, the words "estimated price" mean the price of procurement estimated by the procuring agency before initiation of the process of procurement. (It cannot be demanded on bid price or quoted value)	27
2.	A procuring agency shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least ten days prior to the award of procurement contract.	37



Sr. No	Description of Omission / Violation	Violated Rule / Instructions
1.	Non observance of immediate availability of bidding documents after date of publication.	25 (1)
2.	The procuring agency may require the bidders to furnish a bid security not exceeding five percent of the estimated price. Explanation; - In this rule, the words "estimated price" mean the price of procurement estimated by the procuring agency before initiation of the process of procurement. (It cannot be demanded on bid price or quoted value)	27
3.	Any of the total bids can only be rejected on the basis of evaluation criteria. Though, (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal (2) The procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.	35
