This is with reference to GCU, Faisalabad's Tender Notice, published in daily "Dawn" on 23rd January, 2018. It is observed that the advertisement is in violation of the Violation of Punjab Procurement Rules 2014.


As per the advertisement, 15 days of response time is not given and the last date for submission/opening of tenders is on 31-01-2018, which is 6 days short. It is violation of PPRA Rules 2014, No.14 (1). Stated as under;

14. Response time:- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
