Sub: Violation of Punjab Procurement Rules 2014, District Police Officer, Police Department, Rahim Yar Khan's Tender Notice for Miscellaneous Works.

This is with reference to Police Department, Rahim Yar Khan's Tender Notice, published in daily "The Nation" on 22nd January, 2019. It is observed that the advertisement is in violation of Punjab Procurement Rules 2014.

As per advertisement, "Scope of the advertised works can be increase/ decrease the quantities as per availability of funds", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPRA 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:

(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:

(iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Tender documents ~~Rs.50/-~~ (non refundable) of each item will be charged. The offers shall be accepted only with original bidding documents. Photocopies would not be accepted.

TERMS & CONDITIONS:-
Each bid shall comprise a single sealed package containing two separate envelopes as under

- 1). TECHNICAL PROPOSAL** (Detail of specifications, make, country etc on the terms & letter head pad alongwith catalogue, bidding documents, earnest money for respective item).
- 2). FINANCIAL PROPOSAL** (Rate of respective item including all taxes/ charges whatsoever, as per following form on the firm's letter head pad):-

The envelopes should be marked in bold letters as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" respectively with name of item.

- Technical Proposal will be opened on 06.02.2019 at 10.30 hours while Financial Proposals shall remain (in sealed form) in the custody of the DPO Rahim Yar Khan and would be opened after receipt of the technical report, in the presence of bidders. The technically qualified lowest bid would be accepted. The financial proposal of bids found technically un-acceptable shall be returned un-opened to the respective bidders.
- The bidders shall submit Earnest Money with their technical proposals as need against each work in the shape of Pay Orders/ Bank Drafts of any scheduled Bank in favour of the District Police Officer, Rahim Yar Khan in case of non-acceptance of tenders the earnest money will be refunded after finalization of the tender.
- In case of acceptance of tenders, the bidders shall deposit a security @ 5% of the total value of work in the form of Deposit at Call in the name of the District Police Officer, Rahim Yar Khan, and draw the contract agreement. Security shall be refunded on successful completion of the contract.
- Bids will be received till 06.02.2019 at 9.30 hours and will be opened on the same day at 10.30 hours.
- Any of the total bids may only be rejected on the basis of evaluation criteria Though.
 - The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
 - The procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be justify those grounds.
 - The procuring agency shall incur no liability, solely by virtue of its invoking sub-rule (1) towards the bidders.
 - The bidders shall be informed promptly about the rejection of the bids, if any.
- On completion of work, if the same is not found according to the standard specification / up to the satisfaction of District Police Officer, Rahim Yar Khan, or in case of failure to complete the work according to the contract, the security can be forfeited which may also result in blacklisting of the firm
- Scope of the advertised works can be increased/ decreased as per availability of funds.
