**Sub: Violation of Punjab Procurement Rules 2014, Medical Superintendent, Tehsil
Headquarters Hospital, Kabirwala's Tender Notice for Local Purchase of Medicine/
Surgical Items.**

Dear Sir,

This is with reference to Tehsil Headquarters Hospital, Kabirwala's Tender Notice, published in daily "Khabrain" on 22nd July, 2018. It is observed that the advertisement is in violation of the Violation of PPRA 2014.

As per advertisement, there is an ambiguity; as in the paragraph mentioned the bid submission date is given as 11-08-2018 and opening is kept on the same day, while in the table the bids opening date is given as 12-08-2018. It is violation of Punjab Procurement Rules 2014, Rule 30(1). Stated as under;

30. Opening of bids.— (1) The date for opening of bids and the last date for the submission of bids shall be the same; and, bids shall be opened at the time specified in the bidding documents which shall not less than thirty minutes after the closing time for the submission of bids.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Bidding shall be conducted through Open Competitive Bidding (Single Stage-Two Envelope) procedures specified in the Punjab Procurement Rules PPRA 2014 (amended up to March 2017 and any other subsequent amendments), and is open to all eligible bidders as defined in the bidding document.
- Interested eligible bidders may obtain bidding documents and further information from the office of undersigned on submission of written application along with payment of non-refundable fee of RS. 1000/- (One Thousand Only). Bidding documents are available till 11-08-2018 up to 10:00 am from office of Medical superintendent, THQ Hospital, Kabirwala.
- Bidding documents are also available on Punjab Procurement Regulatory Authority website (www.ppra.punjab.gov.pk) until the closing date for the submission of bids.
- Sealed bids must be delivered to the above office on or before 11th August, 2018 up to 12:00 Pm and must be accompanied by a Bid Security amounting 70,000/- in the form of CDR, Pay Order, Demand Draft or Banker's Cheque from a Scheduled Bank of Pakistan.
- Bids will be opened in the presence of bidder's representatives who choose to attend at 12:30 Pm on the same day in the office of medical superintendent THQ hospital Kabirwala on the closing date.
- In case of any conflict between Bidding Documents and PPRA Rules, the rules shall prevail.
- Taxes will be deducted from invoices as per applicable government rules.
- NTN and Sales Tax registration and other relevant documents must be provided.
