
As per the advertisement, the receiving date of bids is given as 06-12-16 while the opening date is given as 10-12-2016. It is violation of Punjab Procurement Rules 2014, Rule 30(1). Stated as under;

***30. Opening of bids.**— (1) The date for opening of bids and the last date for the submission of bids shall be the same; and, bids shall be opened at the time specified in the bidding documents which shall not less than thirty minutes after the closing time for the submission of bids.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the notice under the prescribed procedures or issue a corrigendum and extend date accordingly.

PURCHASE OF PHARMACOPOEIAL REFERENCE STANDARDS (RS) AND CALIBRATED WORKING STANDARDS) FOR DRUGS TESTING LABORATORY PUNJAB, LAHORE.

Primary & Secondary Healthcare Department, Government of the Punjab, invites sealed bids (Technical & Financial) from the Manufacturers/Sole Agents; for the purchase of pharmacopoeial reference standards (RS) and calibrated working standards. The offer (s) shall be separately evaluated against pharmacopoeial reference standards and traceable working standards. The bidder shall quote both/either (C&F, DDP) prices. The lowest price will be determined by comparing C&F prices with C&F Prices and DDP Prices with DDP prices.

2. The Bidding documents including detailed specifications, quantity, terms & conditions are available on the websites (www.pshealth.punjab.gov.pk) and (www.ppra.punjab.gov.pk).
3. Bidding shall be conducted through Single Stage – Two Envelopes bidding procedure of Punjab Procurement Rules, 2014. The bids shall clearly be marked with Tender Enquiry No. for which the proposal is submitted.
4. Sealed bids are required to be submitted by the Bidders on or before 6th December, 2016 (Tuesday) till 11:00 AM positively in Procurement Cell of the department. The bids received till stipulated date & time shall be opened on 10th December, 2016 (Tuesday) till 11:30 AM in the presence of the bidders or their authorized representatives. Late bids shall not be entertained.
5. All bids should be submitted in Tape Binding. All documents should contain proper page marking, attached in sequence as indicated for evaluation in the Bidding Documents and signatures of authorized person. Moreover, signing and stamping of each page of bidding documents/form is mandatory.
6. In case the date of opening or last date of sale is declared as a public holiday by the government or non-working day due to any reason, the next official working day shall be deemed to be the date of sale and submission and opening of tenders accordingly. The time and venue shall remain the same.
7. You are requested to give lowest and best prices with bids as no negotiations on the prices are allowed.

Note: The procurement shall be governed by the Punjab Procurement Rules, 2014.
