

Subject: **Violation of Public Procurement Rules 2004, Director Works, University of Gujrat, Hafiz Hayat Campus, Gujrat's Tender Notice for Construction of 8 Family Apartments**

Please refer to your office letter No. TL 17/3110/9A dated 31-10-2017 on the subject matter. In this connection, the matter has been examined and requisite reply / comments are presented as under;

1. That the bidding / tender documents fee of Rs. 10,000/- (non-refundable) has been charged in accordance with notification of Govt. of the Punjab, Secretary (C&W) Department, No. B-II(C&W)2-11/78/Procumbent(2014) dated 03-02-2015 (**Annex-A**), for which, the University of Gujrat as procuring Agency is authorized under section 25(7) of the PPRA rules.
2. That, the PPRA section 25(5) as referred in your letter doesn't relate to the subject matter. Therefore, we Consider it as lack of informations at your part
3. That the above said observations and communicated as violation of PPRA rules are of great concern that damaged creditability of the prime educational institution of the Country. Your observation Stand baseless does not possess any evidence and Supporting documents. The University considers it as an unnecessary interference in its official working.
4. That the University of Gujrat follows proper procedure / codal formalities for its development works as prescribed in its works rules. All codal formalities are ascertained by a high level tender committee and works committee for ensuring transparency in the tender process and open competition as per procedure of the PPRA rules.

Foregoing the facts stated above, letter bearing No TL 17/3110/9A dated 31-10-2017 may be rescinded henceforth.
