Apropos letter No.TL19/2101/IA dated 21-01-2019 on the subject cited above.

I am directed to submit here that Board of Intermediate & Secondary Education, Lahore is a statutory body established under the provisions of the Punjab Boards of Intermediate & Secondary Education, Act 1976. The primary function of the Board is to organize SSC & HSSC Examinations in smooth and transparent manner. It is worth mentioning here that the Board of Intermediate & Secondary Education, Lahore is the only Board of Pakistan which conducts Examinations of almost one million candidates. For the conduct of examinations the office has to constitute almost 850 Examination Centers for Secondary School Examination and 600 for Intermediate Examination across Lahore Division i.e. District Lahore, Kasur, Sheikhpura, Nankana sahib and in all over Punjab for Danish Schools. It is the core responsibility of the Board to make logistic arrangements for provision/collection of Answer books, Question papers and other relevant Examination materials to the Examination Centers and Banks. In this context the office has to hire vehicles services on rent basis and obtain rates of vehicles through Tender so that the office may use vehicles on day to day basis as per actual requirements for the period specified for Examinations.

The Tender notice under reference has been published in daily newspaper as well as uploaded on PPRA website for 12-15 shahzore loaders vehicles for provision / collection of Answer books/ Question papers and other relevant materials to Examination Centers and Banks.
