Sub: Violation of Punjab Procurement Rules 2014, Executive Engineer, Public Health Engineering Division, Khushab's Tender Notice of Rehabilitation/ Augmentation of Rural Water Supply.

Dear Sir,

This is with reference to Public Health Engineering Division, Khushab's Tender Notice, published in daily "Khabrain" on 21st June, 2018. It is observed that the advertisement is in violation of the Violation of Punjab Procurement Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for the submission/ opening of tenders is given as 30-06-2018, which is 5 days short. It is a violation of PPRA 2014, Rule No.14 (1). Stated as under;

14. Response time:- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

The tender/bidding documents will be issued by the Divisional Head Clerk of this office upto 29.06.2018 during the office hours on production of 32 A Challan form of tender fee/ printing charges deposited in National Bank of Pakistan paid on or before 28.06.2018 as admissible under the rules. Tender rates and amounts should be filled in figures as well as in words. Tender should be signed as per general direction given in the tender documents.

Tender will be received in the office of Commissioner, Sargodha Division, Sargodha up to 1.00 PM on the date of receiving of tenders and will be opened after 30 minutes by the Tender Committee in the presence of intending contractors or their representatives. Conditional Tenders will not be accepted. Undersigned may reject all bids or proposal at any time prior to the acceptance of a bid or proposal and shall, upon request communicate to any bidder the grounds for its rejection of all bids or proposal but shall not be required to justify those grounds. Tenders not accompanied with **2% estimated price** in the shape of deposit call of scheduled Bank, will not be entertained.

"As per amendments by the Finance Department notifications No. RO (Tech) FD. 1-2/2010 dated: 04.09.2012 in tender document/contract form for execution of works". The lowest evaluated bidder will have to deposit additional performance security from the schedule Bank equal to the tender amount below estimate cost within 15 days of receipt of notice or within expiry period of the id whichever is earlier.

Performance security as per PPRA Rules 2014, clause No.56, Chapter VIII will be applicable.
