Sub: Violation of Punjab Procurement Rules 2014, Deputy Director, Parks and Horticulture Authority, Faisalabad's Tender Notice for Development/ Improvement Works.

Dear Sir,

This is with reference to PHA, Faisalabad's Tender Notice, published in daily "Dawn" on 24th October, 2016. It is observed that the advertisement is in violation of the Punjab PRA 2014.


As per the advertisement, the tender fee for work under Sr. No.1 is given as PRs 11,500/-, which appears costly in light of the Procurement Rule and is violation of Punjab Procurement Rules 2014, Rule 25(7). Stated as under:

25. Bidding documents.- (7) The procuring agency shall, on payment of such fee as the procuring agency may determine keeping in view the cost of printing and provision of the documents, provide a set of bidding documents to the prospective bidders.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- 1 Tender documents can be obtained from the office of the undersigned immediately on payment of **prescribed tender fee** from the date of publication on PPRA till the 14.11.2016 against written request accompanied with attested copies of:-
 - i. Registration certificate issued by PRA (Punjab Revenue Authority).
 - ii. Enlistment / up-to-date renewal letter along with proof of fee deposited for enlistment/ renewal.
 - iii. Pakistan Engineering Council License for the year-2016.
- 2 Tender rates and amount should be filled in figures as well as in words and should be signed as per general directions given in the tender documents. No rebate on tender rates will be acceptable.
- 3 The tender fee shall be deposited in the shape of C.D.R. and not in cash at the time of submission of application for issuance of tender form.
- 4 Conditional tender and tenders not accompanied with Earnest Money in favour of Deputy Director Engineering PHA Faisalabad at the rate of 5% of the estimated cost in shape of Deposit at Call receipt from scheduled Bank. **Tender will be issued on showing the C.D.R** and tender without earnest money will not be accepted.
- 5 Tenders will be received in the office of the undersigned upto 12:00 Noon, the receiving/ opening of tenders and will be at 12:30 PM, thereafter by the tender opening committee in presence of intending contractors or their representatives.
- 6 The procuring agency may reject bids or proposal at any time prior to the acceptance of a bid or proposal, however the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.
- 7 The Competent Authority reserves the right to reject the tenders without assigning any reason thereof.
- 8 Declaration on stamp paper worth Rs. 100 that his firm has not been blacklisted by any department/ executing agency.
- 9 Proof by the contractor that his firm has executed at least 2 major works in the parks in any PHA.
- 10 If the representative of the contractor intends to obtain tender document, he would submit authority letter from the contractor.
- 11 Submission of bank statement showing at least **Fifteen Lac** available as a balance and also showing the transaction of the same amount or above during the preceding six months.
