Sub: Grievance – Misprocurement Against Tender Regarding Hiring Of Firm For Group Life Insurance For LDA Employees

Respected Sir,

This has reference to your letter No. LDA/DC&I/DDP/394 dated 19th September 2019 received on 24/09/2019, regarding the subjected matter.

It is regretfully highlighted that the content of your correspondence is not based on factual position. The concerned authorities of LDA has neither given the technical evaluation report on PPRA Punjab website (whereas it was mandatory) nor any formal intimation to State Life was made.

The only intimation received was a WhatsApp message (copy attached) from the cell number 0309-9997778 of Mr. Hussain Shah intimating the proceedings of technical evaluation report on 16th August 2019 (Friday), whereas the technical evaluation report was issued on 08th August 2019. The very next working day i.e. Monday 19th August 2019 we submitted our grievances to Director General LDA and Director C&I as acknowledged in your letter.

As we responded immediately according to your WhatsApp message, hence the clause of delay from bidder does not stand in our case.

Therefore it is apprehended that State Life was deliberately barred by not communicating the tender proceedings and hence sheer violation of PPRA rules was made by your prestigious organization. Hence we reserved the right to follow up our complaint till the settlement of our grievance, and request to stop further proceeding regarding this tender.

Evaluation Report

In terms of Rule 32 read with rule 37 of Punjab Procurement Regulatory Rules 2014, "A procuring agency shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least ten days prior to the award of procurement contract."

The Connotation of the aforementioned rule and inference thereof leads to the fact that evaluation report means combination of technical as well as financial evaluation. As compliance of rule ibid requires uploading of complete evaluation report where after the procuring agency after a pause of 10 days enters in to contract therefore, it is advised to follow the PPRA Rules and upload the complete evaluation report on PPRA website instead of technical report only.
