This is with reference to FIEDMC, Faisalabad's Bid Notice, published in daily "Dawn" on 23rd August, 2016. It is observed that the advertisement is in violation of the Violation of Punjab Procurement Rules 2014.

The tender fee, for the bidding documents, for works under Sr. No 2 & 3 is charged as PRs 10,000/- in the advertisement, is violation of Punjab Procurement Rules 2014, Rule 25(7). Stated as under;

25. Bidding documents.- (7) The procuring agency shall, on payment of such fee as the procuring agency may determine keeping in view the cost of printing and provision of the documents, provide a set of bidding documents to the prospective bidders.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the bid under the prescribed procedures or issue a corrigendum and extend date accordingly.
