Subject: - **VIOLATION OF PUNJAB PROCUREMENT RULES 2014, PRINCIPAL, DIVISIONAL PUBLIC SCHOOL, LAHORE'S QUOTATION NOTICE FOR PRINTING OF ANSWER SHEET.**

Reference:- Your Letter No. TL16/1912/3A dated 19-12-2016 on the subject.

1. Let me take the opportunity to appreciate your concern for application of rule of law across the board. However, the referred letter has been issued without obtaining proper information and facts about this organization.
2. In this regard, it is submitted that:-
 - a. This institution is incorporated under Societies Registration Act 1860 (Copy of incorporation certificate is enclosed) and is not working in connection with any organ or affairs of Federal or Provincial Govt. or Local Bodies.
 - b. PPRA rules as notified on October 2, 2009 contains in its section No. 3 that:

Scope and Applicability:-

“Save as other wise provided, these rules shall apply to all procurements made by all procuring agencies of the Government of the Punjab whether within or outside the Punjab”.

3. In view of above, it is clear that PPRA rules are not applicable on procurement and contracts of this organization hence question of any violation under the PPRA rules does not arise. It is further pointed out that this Institution has its own set of procedures for procurement and contracts which are duly approved by its Governing Body/Concerned Authorities.
4. There are directions of superior Courts of Province declaring that this Institution is not a Statutory Body.
5. In this regard, a comprehensive reply has already been submitted to your good office vide our Letter No. DPS/MF-1/28716 dated 29-03-2016 in response to your Letter No. TL 16/2203/2A dated 22-03-2016 on the subject.
