Sub: Violation of Punjab Procurement Rules 2014, Principal, Quaid-E-Azam Medical College, B.V. Hospital, Bahawalpur's Tender Notice for Purchase of Re-Tendering of Remaining Medicines.

Dear Sir,

This is with reference to Quaid-E-Azam Medical College, B.V. Hospital, Bahawalpur's Tender Notice, published in daily "The News" on 24th February, 2016. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, the last date of issuance of tender is given as 5th March, 2016, which means bidding documents are not available for the bidders for 15 days. The rule "Response Time" includes purchase of bidding documents for the bidder from the date of publishing of advertisement till the date of submission of bids. Therefore, the advertisement is in violation of PPRA Rules 2004, Rule No.13 (1). Stated as under;

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Tenders will be opened in Committee Room QMC Bahawalpur according to schedule given above in presence of bidders or their authorized representatives who wish to be present at the time of opening.
3. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal As per Clause 35, PPRA rules 2014.
4. Earnest money @ 2% of the quoted items will be in the shape of deposit at call issued in favour of Principal Q.M.C, B.V.H, & J.F.H Bahawalpur, attached with the quotation documents.
5. Procurement shall be governed by the Punjab Procurement Rules 2014.
6. Single Stage -Two envelope bidding procedure (Technical & Financial) as per rule 38 (2) (a) of PPRA rule 2014, shall be applied.
- i) Tenders should be submitted comprising a single package containing two separate envelops. Each envelop will contain separately the financial proposal and the technical proposal.
- ii) Envelop shall be marked as "Financial Proposal" and "Technical Proposal" in Bold and legible letters to avoid confusion. The financial proposal envelop will only be opened after technical approval as per PPRA rules 2014.
- iii) On rejection of Technical Proposal the Financial Proposal will be returned unopened. The institution will not be responsible for any opening of Financial Proposal where it is submitted collectively for all the items, or found opened on submission or not properly sealed.
7. The firms already under process of disciplinary action, defaulter or black listed with any Public Sector organization will not be allowed to participate.
8. The bidders are requested to give their lowest and final Price, since, as far as possible, there will be no negotiation on the price.
9. The firm registered with income Tax & Sale Tax Departments can only participate in the tender.
