Reference:- Your Office Letter No. TL17/1801/3A dated 18-01-2017 on the subject. Previous letter of this office No. DPS/MF-1/29589 dated 26-12-2016 in response to your office letter No. TL16/1912/3A dated 19-12-2016.

1. It has been time and again clarified, lastly vide the referred letter for your reference and record, that this institution is registered under Societies Registration Act, 1860 (Registration Certificate enclosed on Page No.1) and is not a Government Organization/ Public Body.
2. As per letter of the Government of the Punjab No.PA/DS(E)MISC/2010 dated 19-04-2010, Divisional Public Schools are independent and private Institutions (Copy enclosed as Page No.2). Furthermore, copies of decision of superiors courts of province have already been provided to your good office declaring that this institution is not a statutory body.
3. In view of above, it is requested that a clarification may be provided whether PPRA rules are applicable or not on private institutions and the bodies registered under Societies Registration Act and which have been declared by Lahore High Court, Lahore as non- statutory body /non-statutory institution.

Subject: - STATUS OF DIVISIONAL / DISTRICT PUBLIC SCHOOLS (DPS)

Reference discussion with Secretary to Government of Punjab, School Education Department.

2. It is clarified that Divisional and District Public Schools (DPS) are independent private institutions run by the respective Board of Governor. The Government of the Punjab, Education Department does not provide a budget to these institutions nor it has any concern or control over the management of these institutions. The respective Board of Governors is the sole authority for all their matters including service matters and discipline. The PEEDA Act or any other service law does not extend to these schools. Their planning, recruitment, promotions and service rules are the exclusive domain of Board of Governor.
