**Sub: Violation of Punjab Procurement Rules 2014, Medical Superintendent, Tehsil  
Headquarters Hospital, Karor Lal Esan, Layyah District's Tender Notice for Local  
Purchase of Medicines.**

Dear Sir,

This is with reference to THQ Hospital, Karor Lal Esan's Tender Notice published in "Dawn" on 24<sup>th</sup> June, 2018. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, "Purchase Committee of the said THQ Hospital shall be authorized to cancel any tender sans assigning any reason thereof which cannot be challenged before any Court of Law". However, it is not complying with, PPRA 2014 Rule No. 35, which requires that reason should be communicated to bidders. Therefore the advertisement is in violation of Rule No. 35 of PPRA Rules 2014. Stated as under;

*35. Rejection of Bids :- (1) the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.  
(2) the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Sealed discount offers are required from the local authentic pharmacy, not at a distance of more than 3kms off the relevant institute, for the local purchase of medicines for use in Tehsil Headquarters Hospital, Karor Lal Esan with the budget allocated by government. Tender forms as well as other terms and conditions can be had against Rs. 500 (non-refundable) tender fee from the office of Medical Superintendent, THQ Hospital, Karor Lal Esan during working hours. Tenders will have to be submitted in this office within 15 days of the publication of tender advertisement by 12:00 noon and will be opened the same day at 12:30 PM in THQ Hospital, Karor Lal Esan in the presence of tenderers or their nominated representatives. The purchase committee of the said THQ Hospital shall be authorized to cancel any tender sans assigning any reason thereof which could not be challenged before any court of law. Tender form must be supported with the following documents. Any sort of cutting in tender shall lead to rejection of tender. Submit tenders after preparing in accordance with PPRA Rules 2014.

### TERMS & CONDITIONS

1. Separate discount offers will have to be submitted for the following medicines.
  - (a) Medicines of multinational companies
  - (b) Medicines of national companies
  - (c) Disposable surgical items
2. All discount shall apply on the prices fixed by **DRUG REGULATORY AUTHORITY**.
3. The successful bidder will have to deposit a performance guarantee equivalent to 3% of the budget of the relevant institute in the shape of CDR.
4. Medical stores shall not give medicines to patient directly. Store keeper / pharmacist shall give all medicines to patients after defacing them.
5. The discount limit shall be as per Drug Discount and Price Adjustment Rules 2007.

### DETAIL OF DOCUMENTS

1. Two attested copies of identity card.
2. Two attested copies of Sales/Income Tax.
3. The copy of Drug license in pharmacy renewed up to 30-06-2019.
4. Affidavit on a stamp paper to the effect that no other institute has been offered rates lower than Health Department Layyah. If case of difference anywhere, the bidder shall be responsible to pay back the same.
5. The contractor shall also submit the bill, warranty and quality certificate of the medicines supplied. Moreover, the contractor shall be bound to furnish the invoice of the medicines he has purchased them from.
6. Tender shall be enclosed in an envelope bearing Financial and Technical Proposals in separate envelopes. The renewal of license as well as not being blacklisted is a must for technical.
