

Water and Sanitation Agency (WASA), LDA invites the sealed bids from professionally as well as financially sound and Well Reputed Printing firms / Authorized Dealer / Contractors registered with RJR & PRA having atleast (02) years of experience in bulk digital variable printing through frame work contract for one year (Extendable) under PPRA Rules 2014, for Printing of Water Bills /Notice through Outsourcing.

2. The bidding documents are available immediately after publication (2014 PPRA Rule 25(1)) at the office of Director Procurement & Stores 59-F Gulshan-e-Ravi Lahore and a complete set of Bidding Documents can be obtained on submission of written application alongwith payMent of a non-refundable fee of Pak. Rs 1000 (Pak Rupees One Thousand Only).

3. Single stage two envelope bidding procedure will be adopted. Bids (Technical & Financial) prepared in accordance with the instructions given in the Bidding Documents must be accompanied by a Bid Security 500,000/- (Rupees Five Hundred Thousand Only) in the shape of CDR in favour of Director (P&S) WASA which is within 5% of estimated cost. Last date for purchase of bidding documents is 06th November 2018. The Bids (Technical & Financial) must be delivered. at the address given above on 09th November 2018 at 10:30 A.M. The Technical bids will be opened on the same day and the same venue at 11:00 A.M in presence of the bidder's / bidders representatives who choose to participate.

4. Only technically responsive bidders will be qualified for opening of financial bids. Financial bids found technically nonresponsive shall be returned unopened to the bidders.

5. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Punjab PPRA Rules 2014 (Rule-35).

6. Conditional tender will not be accepted.

7. No tender via telegraph or by post will be accepted.

8. Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.

9. Pre-bid meeting will be held on 07-11-2018 at 12:00 P.M.
