Lahore Transport Company is a non-profit organization, wholly owned by the Government of Punjab and registered under Section 42 of the Companies Act, 2017 in the province of Punjab, with the Registrar Joint Stock Companies, Lahore. Lahore Transport Company intends to invite sealed bids from big four (4) Chartered Accountant Firms for "Hiring of Tax Consultant".

Interested bidders are requested to submit sealed bids, clearly mention tender name on envelopes and marked to the DGM (Technical)/Chairman Tender Committee at Lahore Transport Company, 4th Floor, 97-B-D/1, Liberty Roundabout, IEP Building Gulberg-III, Lahore on or before August, 2018 at 11:00am along with documents as mentioned in RFP/bidding documents, the bids shall be opened on same day at 11:30am on the same day in the presence of the bidders or their representatives who may choose to be present.

Terms & Conditions:-

1. Processing fee in the form of Demand Draft/Pay Order of Rs. 2,000/- (non-refundable) favoring Lahore Transport Company must be attached with the Technical Bid. No bid will be entertained without processing fee. Other terms and conditions of bidders are mentioned in the RFP/bidding Documents.
2. The bids submitted after the above referred closing date and time shall be rejected and returned without being opened.
3. The bid security equal to Rs.26 000/- (Rupees Twenty Six Thousand only) (up to 5% of estimated cost) in the form of Demand Draft/Pay Order in favor of Lahore Transport Company must be attached with the Technical Bid, failing which the bid will be considered as non-responsive and shall be rejected.
4. The Bid Security will be returned to the unsuccessful bidder upon award of agreement of successful bidder.
5. Single stage two envelopes procedure will be adopted as per sub rule 2 (a) of Rule 38 of Punjab PPRA rules 2014 (amended in 2017).
6. LTC may reject all bids or proposal at any time prior to the acceptance of a bid or proposal. LTC shall upon request communicate to any company/firm who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
