Reference to your letter No. TL16/2716/6A dated 27<sup>th</sup> December, 2016 as subject above; FWMC sent the Tender Notice advertisement to DGPR for publishing dated 17<sup>th</sup> December, 2016, because, DGPR generated IPL No. necessary to provide at the time of submission of tender on Punjab PPRA Portal for above than 2 million procurement.

In original advertisement of tender notice (Annex-A), wherein date of closing and opening of tender is same, but, DGPR changed the closing date only by itself due to late publishing of advertisement and forgot to change other dates in advertisement accordingly.

Therefore, FWMC did not upload the tender on Punjab PPRA website due to aforementioned reason of DGPR mistake and cancelled the tender notice through advertisement (Annex-B) for avoiding the mis-procurement charge and assure the transparency in procurement process.
