Sub: Violation of Punjab Procurement Rules 2014, Medical Superintendent, Government Teaching Hospital Shahdara, Lahore's Tender Notice for Items and Services.

Dear Sir,

This is with reference Government Teaching Hospital Shahdara, Lahore's Tender Notice, published in daily "Dawn" on 28th August, 2018. It is observed that the advertisement is in violation of the Violation of PPRA 2014.

As per advertisement, 15 days of response time is not given and the last date for the submission/ opening of tenders is given as 07-09-2018, which is 4 days short. It is a violation of PPRA 2014, Rule No.14 (1). Stated as under;

14. Response time:- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Single Stage-Two Envelopes bidding procedure shall be applied. The envelopes shall be marked as financial proposal and technical proposal in block and legible letter. Financial proposal of the bids found technical non-responsive will be returned unopened to the respective bidders.
- Sealed bids are required to be brought in person by the authorized representative of the interested bidders on the proposed date and to be dropped in the tender box by the closing time. The late arrivals and bids sent by post will not be entertained. The tenders (Technical Proposals) will be opened by the purchase committee in presence of the bidders or their authorized agents (if available) in the conference room of Govt. Teaching Hospital Shahdara Lahore.
- The Earnest Money / Bid security @ 2% of estimated price (estimated by procuring agency) in shape of Call Deposit in favor of Medical Superintendent Govt. Teaching Hospital Shahdara Lahore should be attached with the tender documents (Photocopy with Technical Offer and original with Financial Offer).
- Procurement shall be governed under the Punjab Procurement Rules 2014. Tender Notice may be seen on PPRA website (www.ppra.punjab.gov.pk).
- The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any concerned bidder the grounds for its rejection of bids or proposals but it is not necessary to justify those grounds.
