**Sub: Violation of Punjab Procurement Rules 2014, Chief Executive Officer, District Education Authority, Dera Ghazi Khan's Tender Notice for Purchase of Computer Lab Equipment.**

Dear Sir,

This is with reference to District Education Authority, Dera Ghazi Khan's Tender Notice published in daily "Dawn" on 27<sup>th</sup> December, 2017. It is observed that the advertisement is in violation of the PPRA 2014.

As per the advertisement, "the given amount shall be increased or decreased in case of any increase/decrease in the No. of lab items, ", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPRA 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

*59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:*


*(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:*

*(iv) repeat orders not exceeding fifteen per cent of the original procurement;*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

## **TENDER NOTICE FOR PURCHASE OF COMPUTER LAB EQUIPMENT**

District Education Authority, District Dera Ghazi Khan intends to purchase computer lab items for the current financial year 2017-18. The following amounts are allocated for the computer lab equipment

1. Rs.13.542 M for high schools (boys & girls) Schemes for the year 2016-17
2. Rs. 41.9916 M for high schools (boys & girls) Schemes for the year 2017-18
3. Rs. 5.00 M for middle schools (boys & girls) Schemes for the year 2017-18

Sealed tenders for purchase are invited till 12:30pm of 18-01-2018. Tenders shall be received by registered post/courier service which shall be opened the same day, 18-01-2018, before District Procurement Committee in the presence of tenderers at 01:00pm. Tender forms along with required list of stores can be had separately from the office of undersigned against Rs.1000/- during working hours.

### **TERMS & CONDITIONS**

- 1 Firm must be Sales Tax paying and registered. Tenderer shall enter his Sales Tax registration No. in tender.
- 2 Quotation must be accompanied with a call deposit of 2% in favor of Chief Executive Officer, District Education Authority, Dera Ghazi Khan as earnest money. However, successful firm shall have to deposit a further 3% call deposit prior to getting supply order.
- 3 All tenderers shall be bound to comply with stipulated instructions/terms and conditions.
- 4 Firm must submit with tender an affidavit on a stamp paper of Rs.100/- denomination to the effect that the firm is neither disqualified/blacklisted by any govt. department nor involved in litigation.
- 5 Firm, in case of approval of tender, shall be bound to deliver/install items at schools at its own expense.
- 6 The rates given by firm must be General Sales Tax inclusive. All taxes imposed by govt. shall be on the firm. Sales Tax invoice be provided.
- 7 Tenderers must bring samples along at the meeting, and incomplete, dubious as well as late received tenders shall not be entertained.
- 8 Technical Bids and Financial Bids must be packed separately in one envelope.
- 9 Tenders shall be opened in the office of Deputy Commissioner, Dera Ghazi Khan, before District Procurement Committee and firm/companies' owners, representatives on 18-01-2018 at 01:00pm, wherein no amendment shall be made.
- 10 The firm given supply order must supply items within the stipulated date or else its security shall be forfeited and further proceedings initiated.
- 11 All purchase shall be made in the light of Punjab Procurement Rules (PPRA)2014. If any new condition is imposed, the tenderer shall be bound to adhere to the same.
- 12 Tenders delivered by hand shall not be acceptable. And any sort of cutting in tender shall not be allowed.
- 13 The given amount shall be increased or decreased in case of any increase/decrease in the No. of lab items.
- 14 District Procurement Committee reserves the right to reject tender partially or in total under PPRA Rules. Its decision shall be final which could not be challenged in any court of law.
- 15 Other general terms and conditions/specifications shall be as per the tender documents and govt. rules and regulations.
- 16 This tender can also be visited on PPRA website.
