**Sub: Violation of Punjab Procurement Rules 2014, Chief Executive Officer, District Education Authority, Faisalabad's Tender Notice for Supply of Miscellaneous Items in Government Elementary/ High Schools (Boys & Girls) in district Faisalabad.**

Dear Sir,

This is with reference to District Education Authority, Faisalabad's Tender Notice published in daily "Nawaiwaqt" on 25<sup>th</sup> November, 2017. It is observed that the advertisement is in violation of the PPRA 2014.

As per the advertisement, "the quantity of purchasable items can be increased or decreased by the authority", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPRA 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

***59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:***


***(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:***

***(iv) repeat orders not exceeding fifteen per cent of the original procurement;***

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

### Terms and Conditions

- The interested parties are required to submit their "Technical Proposals" and "Financial Proposals" in separate envelopes latest by 12<sup>th</sup> December, 2017 at 1.00 pm in the office of the Chief Executive Officer (DEA) Faisalabad and shall be opened by the Procurement/ Tender Committee on the same day at 02:00 pm in the presence of bidders or their representatives.
- Tender form containing detailed specifications, terms and conditions for Furniture and I.T. Labs Equipment's will be issued by the Procuring Agency i.e. Chief Executive Officer (DEA) on payment of Rs.500/- per copy (Non Refundable).
- CDR @ 4% of the estimated bid price must be attached with tender form in the name of Chief Executive Officer (DEA) Faisalabad.
- Firstly only "Technical Proposals" will be opened and afterwards "Financial Proposals" will be opened on appropriate date and time after the receiving of technical report of Technical Committee in the presence of qualifying bidders.
- The procurement agency can reject all the bids or proposals at any time prior to the acceptance of the bid proposal but the procurement agency shall upon request by any supplier or contractor who submitted a bid or proposal provide, the grounds of rejection of bids or proposals, but shall not require to justify those grounds.
- In house wood seasoning facility should be available by the firm.
- Sound financial position of five years bank statement should be attached.
- Fully mechanized furniture manufacturing unit with standardized output.
- One sample of each item to be provided to check the quality and workmanship of the firm at the time of opening of technical bids (In case of furniture items only).
- Minimum ten years' experience of manufacturing furniture should be submitted with the tender.
- Only the lowest evaluated financial proposal will be accepted.
- Commissioning of the labs as per schedule chalked out by the client would be the responsibility of the supplier.
- Suppliers can quote rates in all or anyone of category.
- Detail of all terms & conditions is mentioned in tender document.
- All leviable taxes will be paid by the supplier as per Rules & Policy.
- The Quantity of the purchasable items can be increased or decreased by the authority.
- The suppliers should provide the supplied items within stipulated time as mentioned in the supply orders.
- Punjab Regulatory Authority Tax according to Govt. Policy will be applicable.
- Stamp Duty/Tax will be paid by the firm as per policy.
