Sub: Violation of Punjab Procurement Rules 2014, Executive Engineer, 2nd Building Division, 6-Meclod Road, Lahore's Pre-Qualification Notice for Procurement of Passenger/Bed Lift.

Dear Sir,

This is with reference to 2nd Building Division, Lahore's Pre-Qualification Notice, published in daily "Jang" on 1st January, 2018. It is observed that the advertisement is in violation of the PPRA 2014.

1. As per advertisement, 2nd Building Division, Lahore has restricted the bidder to supply Passenger/Bed Lifts originated of USA, West Europe & Japan only and has not added "**or equivalent**" with it, which is not allowed under PPRA 2014, Rule No. 10(2). Stated as under:

***10. Specifications:** - (2) The Specifications shall be generic and shall not include references to brand names, model numbers, catalogue numbers or similar classifications but if the procuring agency is satisfied that the use of, or a reference to, a brand name or a catalogue number is essential to complete an otherwise incomplete specification, such use or reference shall be qualified with the words "or equivalent".*

2. Also, 15 days of response time is not given and the last date for submission/ opening of applications is on 11-01-2018, which is 4 days short. It is violation of PPRA 2014, Rule No.14 (1). Stated as under;


***14. Response time:-** (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.

6. Detail of works in hand indicating name of Client Department, consultants, scope of works.
7. Authentic proof of their financial position such as Bank statement of the pervious one year.
8. Income Tax Registration Certificate.
9. Any further particulars, the firms wish to furnish.

The prequalification applications shall be evaluated on the basis of Planning & Development Department criteria for prequalification. The other related information required in this regard should also be provided.

Any further information / details in this connection may be obtained from the Executive Engineer 2nd Building Division, Lahore on any working day. Only pre-qualified firms will be invited to participate in tenders. The competent authority reserves the right to accept or reject the pre-qualification as per PPRA rules.
