Sub: Violation of Punjab Procurement Rules 2014, Additional Deputy Commissioner (F&P), District Purchase Committee, Sialkot's Tender Notice for Requirement for Establishment of Ramadan Bazaar.

Dear Sir

This is with reference to District Purchase Committee, Sialkot's Tender Notice, published in daily "The Nation" on 27th April, 2018. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, "items and their quantities to be procured can be reduced or increased as per requirements of Ramadan Bazars", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPRA 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

*59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:
(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:
(iv) repeat orders not exceeding fifteen per cent of the original procurement;*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

i.	Technical proposals/bids can be submitted by hand or through post till 10 th May 2018 at 1.30 PM, in the office of Deputy Commissioner Sialkot and will be opened in the presence of bidders on 10 th May 2018 at 2.30 P.M
ii.	A Cash Deposit/Security or bank draft from any scheduled bank @ 5% of the estimated cost in the favour of Deputy Commissioner, Sialkot shall be furnished with the technical proposal.
iii.	The bidder will quote only single rate against each item.
iv.	The lowest bidder will be responsible to complete the work within two days after getting work order. Otherwise the contract awarded will be cancelled and earnest money will be forfeited.
v.	All permissible Govt. Taxes will be applicable
vi.	Incomplete, mutilated or offers received after due date, will not be considered.
vii.	District Purchase Committee/Authority has the right to accept or reject all bids in accordance with PPRA, rules 2014 along with amendments till to date.
viii.	Decision of the district purchase committee/authority will be final & unchallengeable in any court of law.
ix.	All details of items, quality, quantities to be supplied and list of ramzan bazzars being established in district Sialkot can be obtained/seen from the office of Deputy Commissioner, Sialkot. Tenders will be available on PPRA website www.ppra.gov.pk .
