Sub: Violation of Punjab Procurement Rules 2014, Director General, Parks and Horticulture Authority, Bahawalpur's Tender Notice for Construction of Park.

Dear Sir,

This is with reference to PHA, Gujranwala's Tender Notice published in daily "The Nation" on 28th January, 2018. It is observed that the advertisement is in violation of the PPRA Rules, 2014.

As per the advertisement, the tender receiving date is given as 10-02-2018 while the tender opening date is given as 12-02-2018. It is violation of PPRA Rules 2014, Rule 30(1). Stated as under;

30. Opening of bids.— (1) The date for opening of bids and the last date for the submission of bids shall be the same; and, bids shall be opened at the time specified in the bidding documents which shall not less than thirty minutes after the closing time for the submission of bids.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

2. Tendered rates and amounts should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.
3. Earnest money shall be received in shape of Bank draft / Call Deposit issued from any scheduled Bank along with application at the time of issuance of tenders.
4. Any conditional tenders or tenders without earnest money / documents required as above shall not be entertained.
5. In case the total tender's amount is less than 5% of the estimated cost of the lowest bidder will have to deposit additional performance security as per proportionate of lower rate in the shape of bank draft issued from any schedule bank.
6. In case of gazette or local holiday against tabulated schedule, the date shall be considered as next working day; certainly with the same gap between dates of issuance and receipt.

Sealed bids complete in all respect as per instructions in bid documents along with bid security 2% of Estimated Cost in form of demand draft/pay order in the name of DG PHA from a scheduled bank must be delivered in office of Director Engineering PHA till 3:00 PM dated 10-02-2018 and Tender Opening Time at 12-02-2018 at 11:30 AM.
