**Sub: Violation of Punjab Procurement Rules 2014, Secretary District Tender Opening Committee/ District Officer (Roads), Okara's Tender Notice for Rehabilitation, Construction, and Restoration of Roads.**

Dear Sir,

This is with reference to Secretary District Tender Opening Committee/ District Officer (Roads), Okara's Tender Notice, published in daily "Dawn" on 1<sup>st</sup> June, 2016. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, District Officer (Roads), Okara reserves the right to reject any or all tenders without assigning any reasons thereof. It is not complying with Rule No. 35 of PPRA 2014, which requires that reason should be communicated to bidders. Stated as under;

**35. Rejection of Bids :-** (1) *the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.*  
(2) *the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Without fulfillment of the above requirements tender shall not be issued.

Tendered rates and amounts should be filled in figures as well as in words and tenders should be signed as per general directions for the guidance of contractors given in the tender documents. No rebate on tendered rates will be acceptable.

Tenders will be issued after its publication in the print media upto 18.06.2016 during office hours and will be received on 20.06.2016 at 12:00 PM and opened at 12:30 PM (under provision of PPRA Rules 25(1) in the Committee Room of DCO, Okara by the tender opening board in the presence of intending contractors or their authorized representatives. Conditional / abnormal tenders shall not be entertained. The undersigned reserves the right to reject any or all the tenders without assigning any reasons thereof.

The lowest bidder, who will quote the rates less than 5% of the DNIT based on technically approved estimate cost shall have to deposit the additional performance security in accordance to the Govt. of Punjab C&W department Notification No. SOB-I(C&W)2-37/9, dated 29.12.1999 & F.D. Notification No. RO(Tech)FD-1-2/83-VI(P), dated 24.01.2006 in the shape of deposit at call from any scheduled bank equal to the amount difference between DNIT / Bid & quoted amount. Failure to deposit additional performance security within 15 days from the date of approval of tender would result into forfeiture of earnest money (CDR) without further notice and tender shall stand cancelled automatically. Any Bid / Proposal can be rejected under PPRA Rule-35 Sub Rule (1) to (2).
