

Condition No.04

The procuring agency requires bidders to furnish a bid security of one percent of the estimated price in favor of EDO (CD) Hafizabad. The successful bidder has to deposit performance security of 5% of the issued work order. The tender will be submitted by hand / by post till 10-03-2016 at 11:00 am and will be opened on 10-03-2016 at 01:00 pm.


Condition No.05

According to the PPRA rules 2014, rule no.59(c)(iv) "repeat order cannot exceed more than 15% of the original procurement".

Condition No.10

Any of the total bids can only be rejected on the basis of evaluation criteria, though.

- i) The procuring agency may reject all bids or proposal at any time prior to the acceptance of a bid or proposal.
- ii) The procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.
