Sub: Violation of Punjab Procurement Rules 2014, District Coordination Officer/Chairman,
District Disaster Management Authority, Dera Ghazi Khan's Pre-Qualification Notice for
Purchase of Flood Relief Goods.

Dear Sir,

This is with reference to District Disaster Management Authority, Dera Ghazi Khan's Pre-Qualification Notice, published in daily "Express" on 1st August, 2016. It is observed that the advertisement is in violation of the PPRA Rules 2014.

As per advertisement, 15 days of response time is not given and the last date of submission of bids is on 07-08-2016, which is 8 days short. It is violation of Punjab Procurement Rules 2014, Rule No.14 (1). Stated as under:

14. Response time:- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.

1	Food Hampers (Ghee shall be packed in a ply bag separately duly sealed with sealer in addition to its original packing)
2	Rice (2Kg), Atta
3	Drinking Water, Cooked Food, Catering and Transport.

- i. Pre-qualification of firms shall be made in accordance with Punjab Procurement Regulatory Authority (PPRA), Rules 2014.
- ii. Pre-qualification document along with standardized specification of the relief goods/ equipments are available at PPRA's website and also can be obtained from the undersigned's office during the office hours.
- iii. Preference shall be given to those Authorized Dealers/ Distributers/ Wholesalers/ Stockiest/ General Order Suppliers who have their supply set up(s) at District/Divisional level.
- iv. Technical proposal(s) for each Lot shall accompany with a receipt of cash deposit W@ Rs.500/- Draft worth Rs.500/- in the name of District Coordination Officer/ Chairman District Disaster Management Authority, DG.Khan on account of price of pre-qualification documents for each lot pre-qualification documents for each lot shall be considered separately.
- v. Pre-qualification documents which are incomplete, not sealed and late or submitted by other than specified mode shall be returned un-opened.
- vi. Sample of each lot shall be deposited with Executive District Officer (Finance & Planning), DG.Khan at his office within office hours before a day of closing date. Technical proposal must accompany the sample deposit receipt.
- vii. Applications for pre-qualification in sealed envelope must be reached within office hours i.e 10:00 AM not later than 07.08.2016.
- viii. Technical bids shall be opened on the same date at 10:30 AM i.e after 30 minutes of closing time in the presence of firms/ their authorized representatives.
- ix. Applicant will be informed in due course of the result of evaluation of applications.
- x. Only those vendors/ firms will be invited to submit financial proposals who will pre-qualify and who's samples will also qualify under this process.
