**Sub: Violation of Public Procurement Rules 2004, Secretary, Evacuee Trust Property Board,
Lahore's Request for Proposal Notice for Investment.**

Dear Sir,

This is with reference to Evacuee Trust Property Board, Lahore's RFP Notice published in daily "Jang" on 30th September, 2017. It is observed that the advertisement is in violation of the PPRA Rules 2004.

As per advertisement, 15 days of response time is not given and it is mentioned that all offers/sealed bids should reach office within 10 days of this publication of the advertisement, which is 5 days short. It is a violation of PPRA Rules 2004, No.13 (1). Stated as under;

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the RFP under the prescribed procedures or issue a corrigendum and extend date accordingly.
