Sub: Violation of Punjab Procurement Rules 2014, Chief Executive Officer, District Education Authority, Education Department, Dera Ghazi Khan's Tender Notice for Purchase of Computer Lab Equipment.

Dear Sir,

This is with reference to Education Department, Dera Ghazi Khan's Tender Notice, published in daily "Dawn" on 3rd June, 2017. It is observed that the advertisement is in violation of the Violation of Punjab Procurement Rules 2014.

As per the advertisement, "the said amount can be increased/decreased in case of increase/decrease in the No. of Lab Equipment", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPRA 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:

(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:

(iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

TENDER NOTICE FOR PURCHASE OF COMPUTER LAB EQUIPMENT

Education Department, District Dera Ghazi Khan intends to purchase computer lab equipment for the current fiscal year 2016-17. An amount of Rs.13.512 million has been earmarked for the computer lab equipment for (Boys & Girls) high schools. Sealed tenders for purchase are invited up to 01:30 pm of 16-06-2017. Tenders shall be received by registered post/courier service which shall be opened the same day (16-06-2017) before District Procurement Committee in the presence of tenderers at 02:00pm. Tender forms accompanied with list of required stores can be obtained separately from the office of undersigned against Rs.1000/- during working hours.

TERMS & CONDITIONS

1. Firms must be Sales Tax paying and registered. Tenderer shall enter his Sales Tax registration No. in the tender.
2. A call deposit of two percent in favor of Chief Executive Officer, District Education Authority, Dera Ghazi Khan as guarantee shall have to be attached with the quotation. However, the successful firm shall have to deposit further three percent call deposit prior to receiving supply order.
3. All tenderers shall be bound to comply with the stipulated instructions/terms and conditions.
4. Firm shall have to submit with tender an affidavit on a stamp paper of Rs.100/- denomination to the effect that the firm is neither disqualified/blacklisted by any government department nor involved in any litigation.
5. In case of approval of tender, the firm shall be bound to supply items to schools and install the same at his own expense.
6. The rates offered by the firm must be General Sales Tax inclusive. All government imposed taxes shall be on the firm. Sales Tax invoice shall have to be produced.
7. Tenderer must bring the sample along in the meeting and incomplete/dubious and late received tenders shall not be considered.
8. Technical Bids and Financial Bids shall be packed separately in one envelope.
9. Tenders shall be opened in the office of Deputy Commissioner, Dera Ghazi Khan in the presence of District Procurement Committee and firms/companies owners, representatives on 16-06-2017 at 02:00pm wherein no amendment shall be made.
10. Supplying items within the stipulated date is mandatory for the firm given a supply order or else forfeiting its security further proceedings shall be initiated.
11. All purchase shall be made in the light of Punjab Procurement Rules (PPRA) 2014. The tenderer shall be bound to adhere to any new condition if imposed.
12. Tenders by hand shall not be acceptable. And any kind of cutting shall not be allowed in tender.
13. The said amount can be increased/decreased in case of increase/decrease in the No. of lab equipment.
14. District Procurement Committee reserves the right to reject tender partially or totally under PPRA Rules. The decision of committee shall be final which could not be challenged in any court of law.
15. Other general terms and conditions/specifications shall be as per the tender documents and official rules and regulations.
