**Sub: Violation of Punjab Procurement Rules 2014, Medical Superintendent, Tehsil  
Headquarters Hospital, Bhagtanwala, District Sargodha's Tender Notice for Purchase of  
Miscellaneous Items.**

Dear Sir,

This is with reference to THQ Hospital, Bhagtanwala, District Sargodha's Tender Notice, published in daily "Dawn" on 3<sup>rd</sup> October, 2017. It is observed that the advertisement is in violation of the Punjab Procurement Rules 2014.


As per advertisement, 15 days of response time is not given and the last date for submission of tenders is on 12-10-2017, which is 5 days short. It is violation of PPRA 2014, Rule No.14 (1). Stated as under;

***14. Response time:- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for prequalification) from the date of publication of an advertisement or notice keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.***

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

### **TERMS & CONDITIONS**

The following documents must be attached with tender

1. Tenderers append the attested copy of identity card issued by Nadra with tender.
2. Firm attach an attested certificate of registration with Income Tax & Sales Tax Departments
3. Firm submit an affidavit on a stamp paper of Rs.100/- domination to the effect that it is not blacklisted.
4. The rates quoted in tender must be inclusive of all prevalent taxes. No excuse shall be acceptable afterwards.
5. Incomplete tenders and the ones received after stipulated date and time shall not be acceptable.
6. Rates quoted in tender must be on FOR basis which shall stand enforced by 30-06-2018, and tenderers shall be bound to supply against the given rates.
7. The deduction of Income Tax / Sales Tax shall be made at the time of payment of bill as per rules.
8. A call deposit @ 2% of total amount (34,74,000/-), as per the value of items rates mentioned in tender, in favor of Medical Superintendent, Tehsil Headquarters Hospital, Bhagtanwala must be attached with the Financial Bids.
9. All rates be mentioned clearly against the items given in tender form. Rates given other than the ones in tender form shall not be acceptable.
10. All documents must be signed and stamped. No tender shall be acceptable without signature and stamp. Incomplete, scored and amended tenders shall not be acceptable.
