Dear Sir, This same Tender Notice was uploaded on 24th June, 2017 in daily "EXPRESS" (original newspaper attached) and was then republished on June 30th 2017 in daily "DAWN" (original newspaper attached for reference). Procurement Proceedings were commenced after the Initial Publication of Tender on 24th June, 2017 and according to that, Rule NO. 14(1), PPRA 2014 was duly followed as Last date for Tender submission is 08-07-2017 which is fifteen days from June 24th 2017. The proof of Double Publication of the same Tender is the same IPL No being Issued by Directorate General Public Relations Punjab i.e. **IPL 8471** in both the Publications (Original Newspaper attached for referencing) .

Now, about the reasons to this double publication. Originally, a letter was sent to DGPR on June 15th, 2017 vide **Dispatch No 2803** (copy attached of register as well as the Courier Service) dispatch register of DHQ Hospital M.B.DIN.
