**Sub: Violation of Punjab Procurement Rules 2014, Chief Officer, District Council,
Sialkot's Quotation Notice for Purchase of Miscellaneous Items.**

Dear Sir,

This is with reference to District Council, Sialkot's Quotation Notice, published in daily "Nawaiwaqt" on 4th June, 2017. It is observed that the advertisement is in violation of the Punjab Procurement Rules 2014.

As per the advertisement, "the quantity of equipment to be purchased can be increased or decreased keeping in view the budgetary position", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPRA 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:


(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:

(iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.

TERMS & CONDITIONS

The Pay Order/ Demand Draft must be in favour of District Council Sialkot, which will be refunded after satisfactory completion of warranty period in case of successful bidder. - * The admissible taxes shall be deducted at source.
- * An affidavit that firm has neither been involved in any litigation with any party nor has been blacklisted by any government organization.
- * The procurement is subject to successful inspection of the equipments by dealing officers of District Council Sialkot.
- * The purchase will be made strictly in accordance with PPRA Rules. In case of any deviation from the sample, the supply shall be returned without any payment by the District Council Sialkot, earnest money of the firm shall be forfeited and the firm shall be blacklisted for future business with the Government.
