**Sub: Violation of Punjab Procurement Rules 2014, Director General, Punjab Food Authority,  
Lahore's Pre-Qualification Notice for Miscellaneous Services.**

Dear Sir,

This is with reference to Punjab Food Authority, Lahore's Pre-qualification Notice, published in daily "Dunya" on 4<sup>th</sup> June, 2017. It is observed that the advertisement is in violation of the Violation of Punjab Procurement Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for submission of tenders is on 14-06-2017, which is 4 days short. It is violation of PPRA 2014, Rule No.14 (1). Stated as under;

*14. Response time:- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.
