**Sub:** Violation of Punjab Procurement Rules 2014, Admin Officer, Daanish Schools Boys Chishtian's Short Tender Notice for Annual Repair and Maintenance Works.

Dear Sir,

This is with reference to Daanish School Boys Chishtian's Short Tender Notice, published in daily "Jang" on 5<sup>th</sup> June, 2016. It is observed that the advertisement is in violation of the Punjab PRA 2014.

1. As per advertisement, 15 days of response time is not given and the last date for receipt of quotations is on 15-06-2016, which is 4 days short. It is in violation of PPRA 2014, Rule No.14 (1). Stated as under;

*14. Response time:- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

TI-P would like to point out that the subject tender is a routine work and it does not fall under the domain of "emergency" as defined by PPRA 2014. The Rule is stated below for your reference;

*(q) Emergency:- 'emergency' means natural calamity, disaster, accident, war and operational emergency which may give rise to abnormal situation requiring prompt and immediate action to limit or avoid damage to person, property or the environment;*

2. Also, "The Procuring Agency may reject all bids at any time without assigning the reason". It is not complying with Rule No. 35 of PPRA 2014, which requires that reason should be communicated to bidders. Stated as under;

*35. Rejection of Bids :- (1) the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.  
(2) the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
