**Sub:** Violation of Punjab Procurement Rules 2014, Assistant Engineer, LG&CD, Rajanpur's  
Short Tender Notice for Miscellaneous Works.

Dear Sir

This is with reference to LG&CD, Rajanpur's Short Tender Notice, published in daily "Express" on 6<sup>th</sup> October, 2016. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per the advertisement, the tender fee for work is given as PRs 10,000/-, which appears costly in light of the Procurement Rule and is violation of Punjab Procurement Rules 2014, Rule 25(7). Stated as under;

*25. Bidding documents.- (7) The procuring agency shall, on payment of such fee as the procuring agency may determine keeping in view the cost of printing and provision of the documents, provide a set of bidding documents to the prospective bidders.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

8. The work will be executed as per scope provided in the T.S Estimate.

Rates quoted by the Contractors below than 5%, the contractor have to submit amount of difference as performance security in form of CDR within 15-days after the approval of rates, which will be returned to contractor on successful completion of work, otherwise work will be cancelled and earnest money will be forfeited.
10. The contractor would be eligible for issuance of tender who have valid PEC Certificate for the year 2016.
