Sub: Violation of Punjab Procurement Rules 2014, Deputy Director (Engineering), Parks and Horticulture Authority, Multan's Expression of Interest (EOI) Notice for Rehabilitation and Beatification of Shams Parks.

Dear Sir,

This is with reference to PHA, Multan's EOI Notice published in daily "Jang" on 7th November, 2016. It is observed that the advertisements are in violation of the Punjab Procurement Rules 2014.


As per advertisement, no expression of interest document is issued for bidders, whereas as per Rule No. (47), it is mandatory to provide a set of EOI document that should include evaluation criteria for the applicants. Stated as under:

- 47. Expression of interest.-** (1) A request for expression of interest shall be advertised in accordance with the provisions of rule 12 and rule 13.
(2) The expression of interest shall contain the following information:
(a) the name and address of procuring agency;
(b) an appropriate description of the assignment providing scope of the intellectual and professional services required;
(c) closing date and place of the submission of the expression of interest;
(d) **criteria for short listing** or prequalification where required; and
(e) any other information that the procuring agency may deem appropriate to disseminate at this stage.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the EOI notice under the prescribed procedures or issue a corrigendum and extend date accordingly.

 3. Bio-data of regular employees staff especially technical staff with experience and list of project completed by them with the proof of their employment.
 4. List of similar nature project with approved cost works/ projects executed including copy of completion certificate (if any).
 5. A certificate / affidavit that the firm is not blacklisted by any Govt. Department Autonomous Body.
 6. Income Tax Registration and clearance certificate for the past five (5) years. Foreign firms shall provide relevant registration documents of their country of origin
 7. Audited report of the firm of the last two (02) years.
 8. Financial stability certificate issued by scheduled bank.
- The proposals must reach the office of undersigned upto 01-12-2016 in working hours. Incomplete application will not be considered.
9. Shortlisted firms have to submit design proposals / cost proposals for consideration of the Authority.
